

2023 Florida Planning and Zoning Association Annual Conference Preview

The 2023 Florida Planning & Zoning Association (FPZA) conference theme of **Keep Calm and Plan On** is in recognition of the many emerging challenges in our communities that planners are dealing with – addressing housing supply and affordability, promoting inclusion and equity goals, implementing transportation policies that benefit all users, and advancing climate change resilience strategies to name a few...all in a time of broader societal discord. This year's conference will be held at the Aloft Delray Beach June 7th through the 9th. The conference theme acknowledges that planners are having to navigate through a period of unprecedented change while continuing to advance important issues and address the ever-changing needs of their communities. Planners are meeting the challenges head-on, and the field of planning is more relevant than ever.

We have worked hard to identify relevant topics and speakers and have focused on the design of our communities while planning for inclusion and equity, tackling transportation and mobility challenges, and advancing climate change resiliency. We have scheduled keynote speakers and break-out sessions with thought leaders in the field from nationally recognized innovators in city planning, neighborhood design and street design, Victor Dover and one of the most sought-after experts in urban planning and design, well known for helping create new, mixed-use urban districts and the planning, revitalization, and redevelopment of downtowns, David Dixon, as well as authors of the American Planning Association's recently released Equity in Zoning Policy Guide. Break-out sessions include leading local and state thought leaders in ethics, resiliency, community planning, and transportation.

This conference will equip you, as community planners and affiliated professionals, with strategies and tools to handle the daily demands of planning in these challenging times. We will learn what tools and techniques are essential to ensuring our plans, policies,



and programs authentically represent the whole community, not just those who are loudest, and most visible and how to know when we get it right. We will also look at tackling transportation and mobility challenges. A community's street system is one of its most valuable assets. We will hear how planners can help to make these assets work for users of all ages and abilities, not just automobiles. We will understand what is context-sensitive design and where has it been successful in meeting most, if not all, needs as well as what we can learn from projects that did not go according to plan.
